The purpose of this Agreement is to define intentions, in aims and terms of agreement between all the cooperating organizations. The cooperating partners hereby confirm their mutual interest - in the field of gymnastics, sports education, technology and science - wanting to provide international activities as training, teaching, research and exchange, to develop these fields to a higher level. For this purpose all organizations agree to the following forms of cooperation

in the field of training education:

- to exchange experiences on teaching methods,
- to exchange staff members for the purpose of lectures, seminars, etc.,
- to organize practical work;

in the field of research:

- to carry out joint research projects in the fields of mutual interests,
- to exchange scientific and technical information,
- to coordinate research studies,
- to exchange scientific results in a defined subject area,
- to publish the results in this area,
- to organize joint seminars, conferences, symposia, etc.;

in the field of exchange:

- to create the conditions enabling kids, coaches, parents, administrative staff, doctors and other club members, partner Institution,
- to exchange for a period of one semester or its part, or for a time needed to carry out a project work, practical training,
- to exchange sport and cultural groups,
- to assistance in sports equipment and props necessary for the realization of activities.

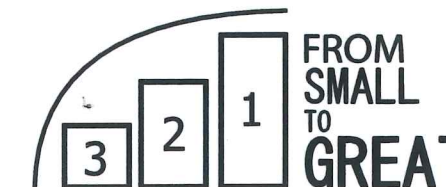
All organizations in the Fromstog Alliance agree to the following **Principles**

1. This agreement does not entail financial obligations for any of the parties to this Agreement.
2. The clubs and institutions intent to make an effort for the purpose of raising funds to realize provisions of this Agreement.
3. The co-operating partners agree to send their members in accordance with the regulations.
4. This agreement is concluded for an unlimited period of time.
5. This agreement enters into force upon signature by representatives of the co-operating partners.
6. Cancellation of the agreement may be effected by any of the clubs and institutions at any time by written notice of termination given to the other cooperating partner.
7. In order to attain specific objectives within this agreement, an 'agenda of interests' will be concluded every two years.
8. All changes and supplements to this Agreement require the signatory consent of all clubs and institutions.
9. New partners can join this agreement after unanimous approval of all involved partners.
10. All future partners need to sign a Declaration of Friendship. This paper will be attached to the Friendship
